Frequently Asked Questions

Is this the same as my will?

An Advance Care Plan is document that functions while you are still living. It captures the type of medical care you want if you're unable make medical decisions for yourself.
A Will (or Last Will and Testament) is a document that functions after your death and instructs how you wish to distribute your money, possessions and property.

Why should I complete this?

Completing an Advance Care Plan ensures your health care decisions are known and respected if you can't communicate them yourself. It provides clear guidance to your care team and those who are about you on your preferences.

Are these legal documents?

Yes. Koda produces state-specific Advance Directives that meet legal requirements for all 50 states. They support you through the proper signing process for your state, whether that's notarization, witnessing, or digital signing.

Do I need a lawyer for this?

Our program produces state-specific legal documents without needing a lawyer.

I already filled out something like this before, do I really need to this?
